

Proposed Electricians (Scotland) Bill

Introduction

A proposal for a bill to provide for the protection of title and registration of electricians. The consultation runs from 19 August to 10 November 2020. All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. Aim and approach

Q1. Which of the following best expresses your view of the proposed Bill?

Fully supportive

Please explain the reasons for your response.

The electrical industry in Scotland and the UK has been unregulated for too long with a number of non qualified individuals undertaking unsafe electrical work or individuals carrying out DIY to an unsafe standard.

Significant amounts of electrical jobs are being carried out particularly in the domestic sector to a poor standard and not being given appropriate certification upon completion which in many cases confirms a lack of knowledge and training.

A standard similar to Gas Safe is required and clarity around what qualifies someone as an electrician. The SJIB recognise SVQ level 3 apprenticeship and the FICA assessment must be completed to be deemed qualified and qualify for a Gold Card.

After this the Advanced Competency assessment to become Approved proving further knowledge and experience for supervising others.

These should be the basic levels required, to meet registration or other qualifications such as the UK AM2 assessment and 2391-52 qualifications.

Q2. What do you think would be the main practical advantages of the proposed Bill?

To remove those carrying out electrical work that isn't in accordance with BS7671 and without appropriate training or competency.

Q3. What do you think would be the main practical disadvantages of the proposed Bill?

Clarifying the required standards to be met for those with industry experience but no formal apprenticeship.

Many have 2391-52, relevant BS7671 2018 qualifications and work to a high standard, it could be they must pass the FICA/AM2 after providing the relevant on site evidence similar to the apprenticeship log book scheme.

Please explain the reasons for your response

Across the 3 sectors I would only foresee a rise in cost in the domestic sector as it is targeted by non trained individuals and those carrying out DIY at home.

Currently within the industry there is a race to the bottom due to non electricians undercutting contractor pricing and domestic customers looking for a cheap price. This is escalated as DIY stores and electrical wholesalers sell to the general public where parts are purchased with no proof of competency. This is a issue that needs addressed as a side issue to reduce DIY electrical work beyond simple tasks.

Q7. Are there ways in which the Bill could achieve its aim more cost-effectively (e.g. by reducing costs or increasing savings)?

Potentially if it were included that the new law surrounding domestic smoke alarms or the potential for AFDD's being required under amendment 2 grants were then made available using registered electricians to offset the cost.

This would improve safety across domestic and commercial/industrial sectors.
