

# Proposed Electricians (Scotland) Bill

## Introduction

A proposal for a bill to provide for the protection of title and registration of electricians. The consultation runs from 19 August to 10 November 2020. All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. SNIPEF and its Members strongly supports the regulation of the Electrical sector by giving Electricians protected title and by the introduction of a unified register.

While Gas Engineers have protected title operating via the GasSafe Register, Plumbers do not and the industry suffers in much the same way as that of the Electrical sector. We would hope that the same recognition could be extended to Plumbers as is being proposed for Electricians.

The Register would provide one central location where consumers could locate an electrician who they would be assured would be qualified to undertake the work. Qualified electricians who hold appropriate qualifications would be recognised for their professionalism and there would be a more level playing field in which they can compete. Currently, this is not the case when individuals who purport to be qualified are not.

Time taken to introduce legislation and set up the register as well as getting those in the industry with no formal qualifications but who are "time served" recognised as competent.

Using the existing Building Standards Certification Register would make sense. Over time this could be expanded to not only show that the individual is qualified but also what specialisms they hold. From a plumbing perspective the individual may be a qualified plumber but they may have gone on further to specialise in renewable work where further qualifications are required.

If this was not to be used then the SJIB register might be an option as this will capture over time a "cradle to grave" approach tracking the individual from the point they enter the industry as an apprentice to when they retire. This would also link to the card scheme encouraging individuals to hold cards to provide evidence of competency and identification.

**Please explain the reasons for your response**

Government and public bodies - while there may be a cost in enforcing regulations, the register if using the Building Standards Certification Scheme is already well established. Government and public bodies would also benefit from using the register when awarding contracts - by using competent professionals they would be assured that the work would be completed right first time.

Businesses - in my experience businesses would be prepared to pay a reasonable amount if the long term effect would be to obliterate "white van man". In addition, insurance companies could have more assurance from a register and in time the reduction in claims might reflect in insurance premiums.

Individuals - may see an increase in cost if they have previously used non-qualified individuals but this

should be outweighed by having the job done right first time and the reassurance that the professional should have the appropriate insurance and a process for recourse should things not go to plan.

Scottish Government could work with insurance sector to link domestic house insurance to using someone on the register. Similarly any insurance claims would require someone on the register to undertake work.
